Divisions: U9-U18 boys and girls developmental teams 5 guest players allowed per team.
U11-U18 boys and girls ALL competitive teams 5 guest players allowed per team.

Entry Fee: U9-U19 Developmental teams \$350.00
U11-U18 ALL competitive teams \$550.00.

A \$50 late fee will be assessed for applications received after the deadline of May 3, 2010. Credit cards, checks or money orders (made payable to Colorado Fusion Soccer Club) will be accepted. Applications will not be processed without the entry fees. **NO EXCEPTIONS.**

Eligible Teams: US Youth Soccer and Affiliated teams. 5 guest players per team for all age groups.
U9-U10 Maximum roster size of 14 players including guest players.
U11-U18 (dev & comp) Maximum roster size of 18 players, including guest players.

Awards: 1st and 2nd place awards in all age groups. Individual medals and a team trophy.

Rules: US Youth Soccer, subject to specified modifications. Rules will be posted on website and distributed to teams with acceptance packet.

Credentials: US Youth Soccer player/coach laminated passes; state approved rosters and approved guest player loan forms. Out of state teams must provide US Youth Soccer travel forms approved by their state associations. All players must have approved medical releases.

Entry Deadline: May 3, 2010. Late registrations may be accepted on a space available basis, with the required late fee, so apply early! Checks, money orders, and credit card payments will be deposited upon receipt.

Confirmation of acceptance of Colorado Fusion Kelvin Norman Memorial Soccer Tournament will be sent to the team's contact information no later than May 16, 2010. Call if early acceptance is needed to finalize travel arrangements.
