**Location:** Aurora Sports Park

**Divisions:** U9-U18 boys and girls developmental teams 5 guest players allowed per team.  
U11-U18 boys and girls ALL competitive teams 5 guest players allowed per team.

**Entry Fee:** U9-U18 Developmental teams \$375.00  
U11-U18 ALL competitive teams \$575.00

A \$50 late fee will be assessed for applications received after the deadline of May 2, 2012. Credit cards, checks or money orders (made payable to Colorado Fusion Soccer Club) will be accepted. Applications will not be processed without the entry fees. **NO EXCEPTIONS.**

**Eligible Teams:** This tournament is unrestricted. US Youth Soccer and its affiliated teams as well as US Club Soccer and its affiliated teams are invited to attend.  
5 guest players per team for all age groups.  
U9-U10 Maximum roster size of 14 players including guest players.  
U11-U18 (dev & comp) Maximum roster size of 18 players, including guest players.

**Awards:** 1<sup>st</sup> and 2<sup>nd</sup> place awards in all age groups.

**Rules:** Rules will be posted on website and distributed to teams with acceptance packet.

**Credentials:** Appropriate player/coach laminated passes; state approved rosters and approved guest player loan forms. Teams outside of Region IV must provide US Youth Soccer travel forms approved by their state associations. All players must have approved medical releases.

**Entry Deadline:** May 1, 2012. Late registrations may be accepted on a space available basis, with the required late fee, so apply early! Checks, money orders, and credit card payments will be deposited upon receipt.

Confirmation of acceptance of Colorado Fusion Kelvin Norman Memorial Soccer Tournament will be sent to the team's contact information no later than May 15, 2012. Call if early acceptance is needed to finalize travel arrangements.
